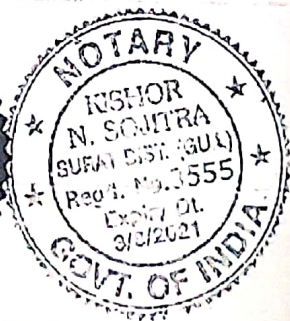
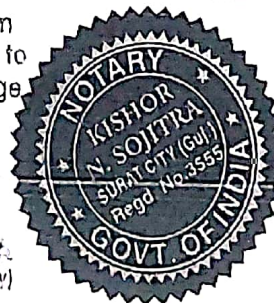

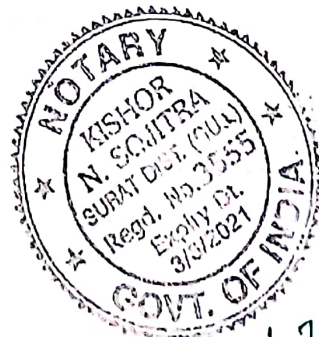

-:: Terms and Conditions ::-

1. At the time of Admission to the school administrator will not take any kind of interviews of Students/Parents and will not take Capitulation fees, Donation and reserved by the school.
2. No Student may admission in the school for lack of evidence of age as well as Religion, caste, sex or birth or thigs may be one reason for the admisson of any of them.
3. The School must ensure that,
 - a. No forbid any Student in a class until completion of primary education is introduced in a school or do not expelled from the school.
 - b. Do not allow to physical fine and mental torture of any student.
 - c. Do not to the examination of the Board until the end of primary education.
 - d. Each student will give a certificate of completion of primary education.
 - e. The qualified teachers will be appointed in accordance with the Mumbai Primary Education Act, 1947 and Mumbai Primary Education Rules 1949.
4. Appointed by the Educational Authority, a state-government curriculum to be taught in school.

9. It will be necessary to have an audit of the financial accounts and necessary statements Certify by a Chartered Accountant of the school and A copy of which shall be sent to the District Primary Education Officer and District Education Officer.
10. Any kind of information sought by District Primary Education Officer, District Education Officer, state government or local organizations to provide from time to time by the school.
